Letter from HxA's President

As we close another extraordinary year in higher education, I am delighted to share with you this annual report of HxA's accomplishments. HxA's work to promote the ideals of open inquiry, viewpoint diversity, and constructive disagreement at our universities has never been more vital. Most importantly, as the report describes, our programs and activities have never been more impactful.

In 2024, we celebrated the first full year of the Mike & Sofia Segal Center for Academic Pluralism.

Made possible by a transformative multi-year grant, the Segal Center is already catalyzing vital research, events, and initiatives that explore the role of pluralism in academic life. The Center's work strengthens our ability to advance institutional change and foster a more inclusive and intellectually vibrant academic culture.

This past year also marked the launch of *inquisitive*, a bold new HxA periodical bringing thought-provoking essays, research, and commentary centered on the core values of open inquiry

and viewpoint diversity. With contributions from thought leaders from around the world, *inquisitive* is poised to become a trusted resource for those seeking fresh perspectives on freedom in higher education.

The second half of 2024 saw the launch of HxA's first dedicated policy team, led by veteran First Amendment attorney and advocate Joe Cohn, Under Joe's leadership, HxA is addressing policy on two critical fronts: governmental and institutional. We are working to ensure that legislation supports—rather than hinders—academic freedom and that university-based policies, including Institutional Neutrality, foster environments where diverse viewpoints and constructive disagreement are not only permitted but actively encouraged. By engaging simultaneously with policymakers and higher education leaders, HxA is shaping a landscape where open inquiry and rigorous debate remain central to the academic experience.

Most importantly, we're continuing to build momentum for the future. Our Campus Community Network blossomed in size and influence in 2024, with 74 active communities now driving cultural and policy changes at institutions across North America and beyond, collectively impacting over two million students each year. These grassroots efforts are not just inspiring—they are reshaping norms and expectations in favor of academic freedom.

As you read through this report, I hope you'll feel the energy and possibility that radiates through the work of our members.

Together, we are not just responding to the challenges of our time—we are building a vibrant, pluralistic, sustainable future for higher education.



Approximately 55% of our funding in CY 2024 was unrestricted, allowing us to invest in strategic initiatives and operations, while 45% was restricted for specific campus communities, research, fellowships, and events.



# **Policy Division**

### HxA Advocates Strong Protections for Open Inquiry

In 2024, HxA established its first dedicated policy advocacy team, hiring nationally-renowned First Amendment attorney Joe Cohn, JD (shown above), to lead. In just under half a year, HxA's Policy Division has established itself as a go-to resource for smart, nonpartisan analysis of emerging laws and regulatory interpretations in the higher ed space.

On the legislative front, HxA's policy team proactively engages with elected representatives to make sure governmental oversight is done in a way that supports open inquiry and avoids requiring forced political speech—allegiance to one ideology or another—in our nation's academic research units and college classrooms.

What about our advocacy on college campuses? The HxA Policy Division has already connected with leaders of over 100 colleges and universities. These engagements have spanned the diverse landscape of higher education, including liberal arts colleges, tribal community colleges, Historically Black Colleges and Universities (HBCUs), state university systems, and Ivy League schools.

These first-round efforts **contributed significantly to the adoption of Institutional Statement Neutrality across America**. Under these policies, leaders commit to generally refraining from taking stances on contested issues, allowing students and faculty to research, learn about, and speak on controversial topics with less fear.

# The Segal Center for Academic Pluralism

### Research Supporting HxA's Mission

Led by Director Alex Arnold, PhD (shown right), The Segal Center for Academic Pluralism is the ideas laboratory of HxA—researching, exploring, generating, testing, and disseminating facts and ideas about open inquiry, viewpoint diversity, and constructive disagreement in higher education.

Besides conducting original research in support of HxA's mission, the Segal Center hosts faculty and postdoctoral fellows from a range of academic disciplines interested in freedom of inquiry and expression. Segal Center fellows conduct original theoretical, normative, and data-driven research and drive wider conversations about truth-seeking and open inquiry in higher ed. In 2024, 80 scholars applied for the positions, with four faculty and one postdoc fellow chosen from the highly competitive pool.





# **Campus Communities**

## HxA Connects and Supports Change Agents

Led in 2024 by Martha McCaughey, PhD, and presently led by Bethany Boucher (shown left), HxA's Membership and Community Engagement team works with a 7,000+ member network of academic leaders to help them strengthen intellectual communities, improve campus cultures, and advance policies that support free and open academic discourse.

In 2024, HxA Campus Communities hosted over 135 group actions, including convening events, developing programming, and effecting positive policy interventions. Highlights include the "Reducing Polarization Dialogue Series" in Colorado, ultimately expanded across all seven Campus Communities in the Mountain West with the tagline "America is too beautiful to be so divided."

This year, Heterodox Communities hosted a total of 63 events. Just one example: HxCanada partnered with McGill University's Campus Community to host "EDI and Academic Freedom: An Honest Dialogue," drawing 400 attendees over two days. With each new conversation, collaboration, and connection that HxA makes possible, we are not just responding to challenges in higher education—we are actively shaping its future.
